# RELEASE HOLD HARMLESS and INDEMNIFICATION AGREEMENT

In consideration of being permitted or permitting a minor for whom the Releasor is the Parent or guardian or for whom the Releasor is allowing to participate in the FERGUSON NORTHERN LIGHTS HOLIDAY CELEBRATION within the City of Ferguson, Releasor for himself and/or his spouse and minors for whom he is the parent or guardian of or for whom he is allowing to participate in the FERGUSON NORTHERN LIGHTS HOLIDAY CELEBRATION 2018, and for his and their legal representatives, heirs and assigns, hereby releases, waives and forever discharges the CITY of FERGUSON and the FERGUSON NORTHERN LIGHTS HOLIDAY CELEBRATION 2018, its subsidiaries, committees, affiliates and its and their officers, directors, elected officials, agents, employees, and volunteers and each of them, herein referred to as "Releasees," from any and all claims, causes of action, loss of damage of any kind whatsoever to Releasor, his spouse and/or minors for whom the Releasor is parent or guardian or for whom he is allowing to participate in the FERGUSON NORTHERN LIGHTS HOLIDAY CELEBRATION 2018 and their legal representatives, heirs and assigns, resulting there from on account of injury to Releasor and/or minors for whom the Releasor is parent or guardian or for whom Releasor is allowing to participate in the FERGUSON NORTHERN LIGHTS HOLIDAY CELEBRATION 2018, their person or property and even injury resulting in death, whether caused by the negligence of Releasees or otherwise while any of them are participating in the FERGUSON NORTHERN LIGHTS HOLIDAY CELEBRATION 2018 including but not limited to the parade on November 25, 2018 and all events relating to said celebration. Releasor, his spouse and/or minors for whom the Releasor is parent or guardian or for whom Releasor is allowing to participate in the above referenced events, hereby agrees to indemnify, save, and hold harmless the Releasees, and each of them from any claims, causes of action, loss or damage of any kind whatsoever, Releasor, for himself and/or his spouse and minors for whom he is the parent or guardian or for whom he is allowing to participate in the FERGUSON NORTHERN LIGHTS HOLIDAY CELEBRATION 2018, might incur due to their participation in any of the herein referenced events by them, whether caused by the negligence of the Releasees or otherwise.

Releasor hereby assumes full responsibility for the risk of bodily injury, death and property damage due to the negligence of Releasees or otherwise while Releasor, his spouse and/or minors for whom Releasor is parent or guardian or whom the Releasor is allowing to participate in any of the herein referenced events, including but not limited to the parade on November 26, 2018. Releasor hereby expressly agrees that this release, Hold Harmless and Indemnification Agreement is intended to be as broad and inclusive as permitted by the laws of the State of Missouri and that if any portion thereof is held invalid, it is agreed that the other portions shall notwithstanding continue in full force and effect. The use of the singular form of expression shall be construed to include the plural and the use of masculine gender shall be construed to include the feminine gender.
